The examples below summarize typical applications associated with each IFRA category under the 51st Amendment. The list is intended as a practical category guide and is not exhaustive; consult the current IFRA guidance when classification is uncertain.

| IFRA Category 12  | Candles of all types; machine-wash detergents with minimal skin contact such as pods/tabs; automated air fresheners and closed-system fragranting products; plug-ins; solid substrates, membranes and sachets; incense; cartridge refills; air-freshening crystals and solid car diffusers; air-delivery systems; cat litter; cell-phone cases; non-skin deodorizers/masks; dryer sheets; fuels; non-spray insecticides such as mosquito coils; joss/incense sticks; machine dishwashing detergents/deodorizers; olfactive games; paints; plastic articles excluding toys; scratch-and-sniff products; scent packs and dry-air scent systems; shoe polish; toilet-rim blocks, toilet gels and scent beads. |
